Leveraging 340B Savings to Improve Care

Safety net providers deliver healthcare to patients regardless of their ability to pay. This underserved patient mix consists of uninsured, underinsured, Medicaid and other vulnerable patients. Established in 1992, the 340B Drug Pricing Program requires drug manufacturers to provide outpatient drugs to Covered Entities at significantly reduced prices. The program is available to several types of safety net health providers, known as Covered Entities, and it allows these providers to stretch the limited federal resources available to them and to offer a comprehensive set of services.¹

The challenge

Shawnee Health Service provides health and social services to residents of southern Illinois and southwest Indiana. Shawnee's 14 community health centers provide affordable, accessible quality healthcare to high-risk and vulnerable populations with comprehensive medical, dental and behavioral health and social services. In 2012, over 146,850 patient visits were provided by 40 physicians, dentists, psychiatrists, physician assistants and nurse practitioners. Specialized medical and social services have been created for pulmonology, obstetrics and gynecology, chronic disease management, adolescent health, mental health, school-based health, and migrant and seasonal farmworkers.

Although, as a safety net provider, Shawnee was already receiving government funds and grants, it found there were significant gaps and a shortage of needed programs for its high-risk and vulnerable patient population.

The 340B program offers Covered Entities the option to contract with pharmacies to dispense drugs purchased through the program on their behalf. Contract Pharmacies help Covered Entities achieve their mission to improve and expand care for their eligible patients by extending their pharmacy services throughout the communities they serve.

The solution

The results

- From January 2012 through March 2014, Shawnee saved just over \$1 million from its six Walgreens Contract Pharmacies through the 340B Complete program
- These savings have allowed Shawnee to continue to **provide quality** and affordable medical care to its uninsured and underinsured patients
